

CONTEST RULES SUNSHINE COAST CREDIT UNION (SCCU)

May 9 Celebration –Prize Draw “Contest”

1. How to Enter

To enter the Contest, submit an official ballot slip into the draw box at any Sunshine Coast Credit Union location in Gibsons, Sechelt or Pender Harbour.

- There is no entry fee and no purchase is necessary to enter this Contest.
- LIMIT one (1) entry per person.
- Contest closing date: In order to be eligible for the Contest, entries must be received by SCCU through an in-person ballot on May 9th 2015 between 11am and 2:00pm Vancouver BC Time.

2. Prize

There are three (3) Prizes available to be won through a random draw consisting of:

One (1) Vancouver Canucks Prize Pack valued at approximately \$735 consisting of two Vancouver Canucks tickets, one overnight hotel stay and an \$85 ferry voucher.

One (1) 16GB Tablet valued at approximately \$650.

One (1) Vancouver Whitecaps FC Prize Pack valued at approximately \$235 consisting of two Vancouver Whitecaps FC tickets and an \$85 ferry voucher.

In no event shall multiple prizes be won by the same entrant.

In no case will SCCU be required to award more prizes than set forth herein, or award a prize other than as specified herein. No cash alternative to the prizes will be offered or provided by SCCU. The prizes are not transferable. Prizes are subject to availability and SCCU reserves the right to substitute any prize with another of equivalent value without giving notice.

3. Eligibility

This Contest is open to residents of British Columbia, nineteen (19) years old or over as of May 9, 2015. SCCU employees, family living in the same household as an employee and directors are not eligible to win the Prizes.

4. Contact Date for Selected Entrants

SCCU will attempt to contact the winners (Selected Entrants) of the Contest by May 15 2015.

5. Selected Entrants Requirements

In order to win a prize, a Selected Entrant must:

- a) Sign a declaration form on behalf of himself or herself:
 - I. Confirming compliance with Contest Rules and acceptance of the Prize as offered;
 - II. - b) Correctly answer a time-limited skill testing mathematical question.
